

WHAT IS COPYRIGHT??

Copyright refers to a bundle of exclusive rights held by the owner in relation to their creative works.

These include the rights to:

- reproduce the work (for example photocopy, print, download or scan it)
- publish it (for example distribute copies for sale)
- adapt to translate it
- perform it in public
- communicate it to the public (for example make it available online or send it by email).

Works protected by copyright include literary works (for example lecture notes, PowerPoint slides Karen Notes) and audio-visual material (for example sound recordings and broadcasting).

Copyright owners also have moral rights:

the right to be properly attributed as the creator and the right to have the integrity of their work respected. This information is provided to help ARIMGSAS students understand their copyright obligations.

DEFINITIONS

Copying refers to reproducing material by any means, for example making a photocopy, recording, scanning and printing.

Communicating refers to the electronic transmission of material, for example uploading to a website, emailing a digital file and making content available via social media or any other sources.
